Handlers must use slip leads when starting their hounds. Muzzles may be used at owner's discretion. All hounds will be slipped from a standing start.

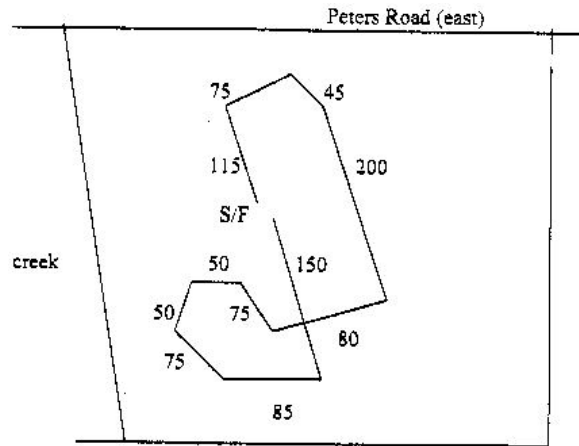

Course Plans

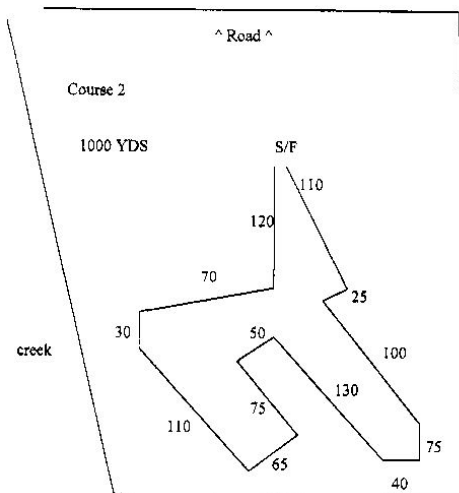
The club reserves the right to alter the course plan as required by weather and/or field conditions on the day of the trial.

It shall be the duty and obligation of the club holding the field trial to see that this regulation is effectively carried out. The Field Trial Chairman shall promptly report to the Canadian Kennel Club any infringement of this regulation, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this regulation has been violated."
